DUE DATES

To be on track, large hospitals (>500 cases/yr.) typically would be expected to have abstracted December 2022 diagnosis cases by July 15, 2023. Smaller facilities (<300 cases /yr.) would be expected to have reported the 4th Quarter of 2022 by July 15, 2023. We will be monitoring reporting timeliness and completeness **closely** in 2023.

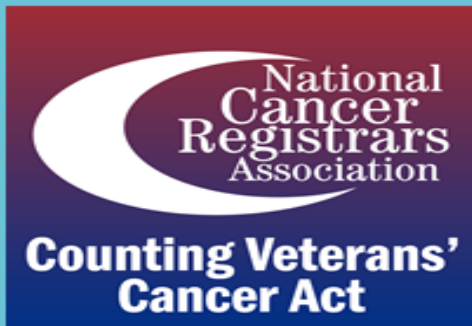

NCRA AND NAACCR APPLAUD SENATORS KELLY AND TILLIS UPON INTRODUCTION OF THE COUNTING VETERANS CANCER ACT OF 2023

On June 14, 2023 Senator Mark Kelly (D-AZ) and Senator Thom Tillis (R-NC) introduced the Counting Veterans' Cancer Act—bipartisan legislation that would ensure veterans' cancer cases are fully accounted for in national cancer registries. Under current reporting laws, it's estimated that each year, tens of thousands of cancer cases among veterans are missed by the central registries that form the

foundation of national cancer research.

Recognizing the long-term inequity of VA facility reporting, NCRA and NAACCR collaborated on seeking a legislative mandate to address this issue. This bill is the next step in the advocacy that NCRA and NAACCR have advanced thanks to Senator Kelly and Senator Tillis.

"Senators Kelly and Tillis' legislation will help identify cancer-related disparities among veterans, improve the understanding of the cancer-related needs of veterans and increase opportunities for veterans with cancer to be included in clinical trials, cancer-related research, and analysis," said Lori Swain, Executive Director of the National Cancer Registrars Association (NCRA). "
