# DUE DATES

To be on track, large hospitals (>500 cases/yr.) typically would be expected to have abstracted July 2022 diagnosis cases by January 15, 2023. Smaller facilities (<300 cases /yr.) would be expected to have reported the 2nd Quarter of 2022 by January 15, 2023. We will be monitoring reporting timeliness and completeness *closely* in 2023.


