DUE DATES

To be on track, large hospitals (>500 cases/yr.) typically would be expected to have abstracted October 2022 diagnosis cases by April 15, 2023. Smaller facilities (<300 cases /yr.) would be expected to have reported the 3rd Quarter of 2022 by April 15, 2023. We will be monitoring reporting timeliness and completeness *closely* in 2023.

ABSTRACTING TIP

New Cervical Histology Codes and p16 SSDI

2021+ HPV associated histologies of the cervix (C530 – C539) and p16 SSDI were not available until the v22 software update. The following histologies are approved for use with primaries of the cervix (C530 – C539) for diagnosis year 2021. Previously, registrars had been instructed to use these histologies for cervical primaries for cases diagnosed January 1, 2022, and forward.

- 8085 Squamous cell carcinoma, HPV-associated (positive)
- 8086 Squamous cell carcinoma, HPV-independent (negative)
- 8483 Adenocarcinoma, HPV-associated (positive)
- 8484 Adenocarcinoma, HPV-independent, NOS (negative)
- 8482 Adenocarcinoma, HPV-independent, gastric type (negative)
- 8310 Adenocarcinoma, HPV-independent, clear cell type (negative)
- 9110 Adenocarcinoma, HPV-independent, mesonephric type (negative)

The new HPV associated cervical histology codes listed in AJCC Cancer Staging System-Cervix Uteri, Version 9 were not available until the software released in 2022. You are able to use those new histologies for 2021+ cases as they are in the 9th version of the AJCC Protocol.

All SSDI's will be set to blank for patients diagnosed in with adenocarcinoma of the cervix in 2021. **You will need to go** back and fix the p16 SSDI data item with the 2022 software update.

NAACCR edits for the HPV histology codes will allow 8085 and 8086 (squamous HPV pos/neg) for Version 9 cervix cases. 8483 and 8484 (adenocarcinoma HPV pos/neg) for any site (including cervix) will trigger an edit for cases diagnosed prior to 2022. That edit will be fixed in v23.

Abstract Plus

MCR is in the process of *phasing out* Abstract Plus. For those who use Abstract Plus currently, we will assist you with transitioning to using **Web Plus**. Abstract Plus will still be available to use for historical data and generating reports at your facility. If you are ready to start abstracting 2022 cases, please contact me so we can get you started on Web Plus. We have already successfully transitioned a few facilities to Web Plus.

Audits Clarification

MCR is required to perform a casefinding audits on facilities every five years. When it is time to audit your facility, we will contact your and ask that you submit your medical record disease index (MRDI) in Excel format for the easing of sorting the data, eliminating duplicates, and comparing to our database. Here is an example of a MRDI:

National Data Quality Standard

Data being evaluated for the National Data Quality Standard (formerly known as the 24-Month Standard) must meet the following five data quality criteria—

- Data are 95% complete based on observed-to-expected cases computed by CDC.
- There are 3% or fewer death-certificate-only cases.
- There is a 1 per 1,000 or fewer unresolved duplicate rate.1
- The maximum percentage of missing critical data elements are
 - o 2% Age
 - o 2% Sex
 - 3% Race
 - o 2% County
- 99% pass a CDC-prescribed set of standard edits.
